SABRIXREPORTS ARCHITECTURE

The underlying architecture of SabrixReports includes a high performance ETL platform that extracts data from the Sabrix tax transaction database, transforms it for reporting and loads it into the Sabrix reporting database. The reporting database is a Class III Operational Data Store (ODS) that can update every 24 hours, and which stores the detailed tax transaction data including all details from the Sabrix audit database. The reporting database utilizes a Star Schema to enable multi-dimensional data views. The entire architecture is tuned for high performance processing and timely reporting against very large volumes of historical tax data.

SabrixReports maximizes the value of your tax transaction data, extends your Sabrix and enterprise reporting architecture investments, and increases the efficiency of your transaction tax management processes. It is one of your most valuable strategic tools for enhancing business performance.
